The undersigned, acting as incorporator of Southeast Youth Development Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is Southeast Youth Development Inc.

ARTICLE II

ADDRESS

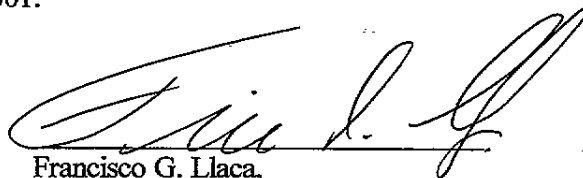

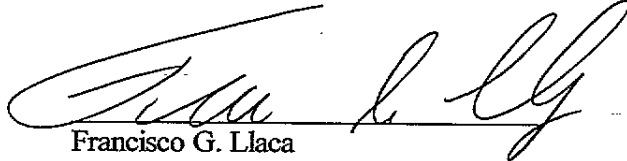
