ARTICLES OF INCORPORATION OF PITTS WORLDWIDE TRADING CO.

The undersigned subscribed to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Pitts Worldwide Trading Co.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSES AND NATURE OF BUSINESS

The amount of capital with which this corporation will begin business is not less than Three Hundred Dollars (\$300.00).

This corporation is to exist perpetually unless sooner dissolved according to law.

ARTICLE VII. MANAGEMENT BY STOCKHOLDERS

The business of this corporation shall be managed by its stockholders rather than by a board of directors. In the management of the business of the corporation, the act of the stockholders representing a majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall be the act of the stockholders. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.
