Article IV - Shares

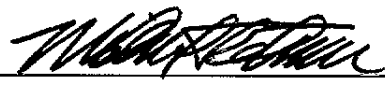
The corporation is authorized to issue 10,000 shares of \$0.01 par value common stock.

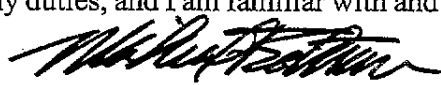
