NAME OF CORPORATION

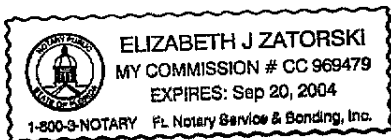




