ARTICLES OF INCORPORATION
OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be TD SUNSHINE COIN LAUNDRY, INC. and the initial address of this corporation shall be 760 West Sample Road, Pompano Beach, Florida 33064.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida, including without limitation, providing carpeting, tile and wood floor services.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE V

The initial registered office of this corporation shall be at the Zimmerman Corporate Center, 2200 W. 
ARTICLE X
