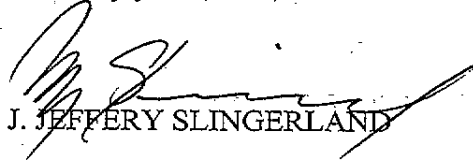

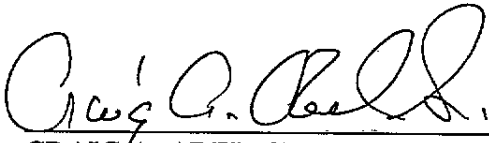
ARTICLE VIII – BY-LAWS

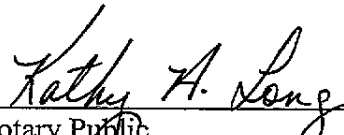

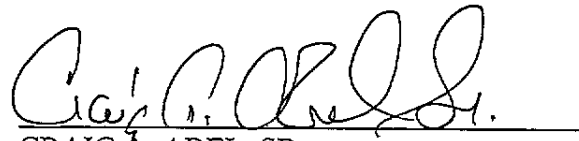
