ARTICLES OF INCORPORATION

ARTICLE I - CORPORATE NAME



ARTICLE X - AMENDMENT

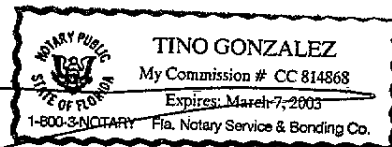
