ARTICLE II - DURATION

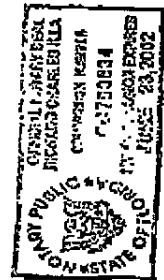
The Corporation shall have a perpetual existence.

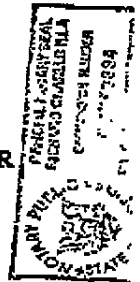
**INITIAL AND PRINCIPAL REGISTERED OFFICE AND AGENT**

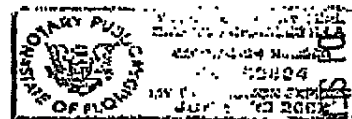
