The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a professional corporation pursuant to the laws of the State of Florida and in compliance with Chapter 607 and Chapter 621 of the Florida Statutes, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I

NAME

The name of this Professional Corporation shall be AccountSource, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business for this Professional Corporation shall be located at 308 Oakwood Court, Lake Mary, Florida 32746.

ARTICLE III

PURPOSE

The specific purpose of this Professional Corporation shall be to render professional accounting, financial and business services to the public including, but not limited to, those professional services rendered by a certified public accountant.

ARTICLE IV

CAPITAL STOCK

This Professional Corporation is authorized to issue 1,000 shares of voting common stock having a par value of One Cent (\$0.01) per share.

COMMENCEMENT OF CORPORATE EXISTENCE

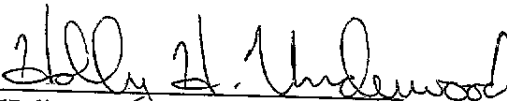
