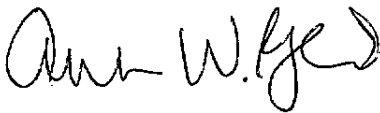

The names and street addresses of the persons signing these articles of incorporation are:

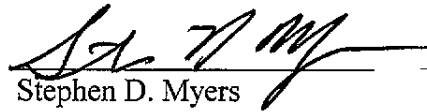
