## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DARMIC CONSTRUCTION AND DEVELOPMENT, IN 2 JUL 22 PM 1: 43

Pursuant to section 607.1006, Florida Statutes, the articles of incorporation of Darmic

Construction and Development, Inc. are hereby changed as follows:

- 1. The current name of the corporation is Darmic Construction and Development, Inc.
- 2. The following amendment to the company's articles of incorporation was adopted by the shareholders on July 12, 2002 as prescribed by law:

The articles of incorporation are hereby amended by changing Article I to read in its entirety as follows: The name of the corporation shall be: Darmic, Inc.

- 3. At the time of such adoption, the number of authorized shares was 10,000; the number of outstanding shares of the corporation was 100 and the number of votes entitled to vote was 10,000; and the number of votes undisputedly represented at the meeting was 10,000.
- 4. The number of undisputed votes cast for the amendment was 100, a number sufficient for adoption of the proposed amendment.
- 5. These Articles of Amendment will become effective at the date and time of their filing.
