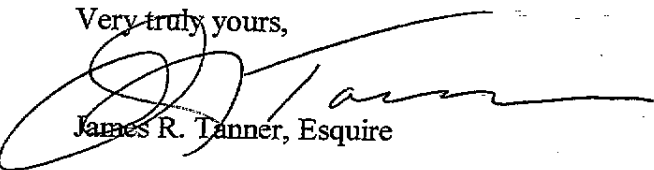

ARTICLES OF INCORPORATION

OF

WENDMIC TRANSPORTATION, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural persons, do hereby act as an incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is WENDMIC TRANSPORTATION, INC.

ARTICLE II

The existence of the corporation shall begin on September 10, 2001.

ARTICLE III
