

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LA PRINCESA KELLY, INC.




The undersigned, being the sele incorporator and director of LA PRINCESA KEILY, INC.., a Fiorida corporation, does hereby certify as follows:
