OF

**Initial Registered Office and Agent**

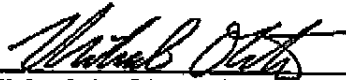

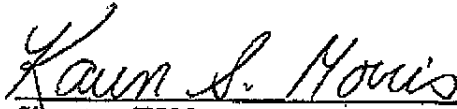
