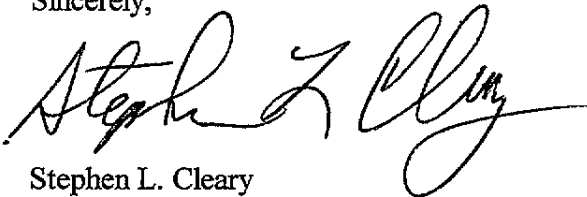

OF

ARTICLE I NAME

The name of the corporation is KVETKO CONCRETE, INC.

Principal address: 765 Middle River Drive, Ft. Lauderdale, FL 33304

ARTICLE II DURATION

This corporation shall exist in perpetuity.

ARTICLE III PURPOSE

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, which shall be designated "Common Stock".

ARTICLE V INITIAL BOARD OF DIRECTORS

ARTICLE VII INCORPORATOR

ARTICLE VIII BY-LAWS

The power to adopt, alter, amend or repeal any and all By-Laws is vested in the Board of Directors.

ARTICLE IX POWERS

This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE X INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XI AMENDMENT
