

I have enclosed a check for \$150.00 for my UBR Filing. I realize that my payment is overdue and am writing to explain the circumstances, hoping to avoid the \$400 late fee, which I do not have. Perkins Consulting is a home based business with virtual offices located at 301 Clematis St, West Palm Beach, FL. We provide Information Technology Consulting and Placement services. The IT industry as a whole has been suffering from mass layoffs and hiring freezes for the past year and a half. As a result, Perkins Consulting has not been doing well financially.

I thought for some reason that the UBR filing payment was due on May 31, not May 1st. I was moving into a different residence at the end of April and thought I had the whole month of May to file, which I planned on doing online. I was waited until the last minute because, as I said, my company is not doing well financially and money is very tight. When I pulled out the form to file online, I saw that I had already missed the filing date by almost a month. I immediately called the FL Dept of State Division of Corporations and they advised me to mail in the \$150.00 and a letter explaining the situation.
