ARTICLES OF INCORPORATION OF NUCLEAR COLLECTIONS, INC.



ARTICLE I

The name of the Corporation is NUCLEAR COLLECTIONS, INC.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
