ARTICLE I-Name

The name of this corporation is Parnell-Maddox Farms, Inc.

ARTICLE II- Principal Office

The address of the principal office and mailing address is 3629 Parnell Road, Zolfo Springs, Florida 38890.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock

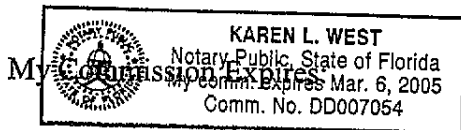




ACCEPTANCE BY REGISTERED AGENT
