
Dear Mr. Scott:

Apparently, the mistake is mine if my UBR is returned for failing to sign #8 ("correction needed"). I interpreted this section to require signature only if the registered agent was being changed; I did not interpret this section as required for reinstating, (as the fine print indicates). I failed to interpret that notation in that latter manner.

I did not return the second notice with the \$400.00 fee because I was under the impression my reinstatement was complete; in addition to the fact that with my original submission in July, I did not believe it was required if submission was timely.

Please waive the reinstatement fees for my corporation. In the future I will be more diligent in interpreting each section, if this is in fact the reason my original UBR was rejected. Thank you for your consideration and patience.
