ARTICLES OF INCORPORATION

OF GREEN START ENTERPRISE, INC

(a Corporation for Profit)

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I- NAME
