ARTICLE IV - CAPITAL STOCK

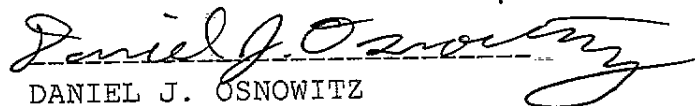

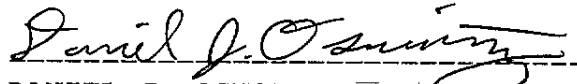
ARTICLE VIII - BY-LAWS
