ARTICLES OF INCORPORATION OF NATURE COAST BUILDING SERVICES, INC. SECRETARY OF STATE TALLAHASSEE, FLORIDA

Article I. Name.

The name of this corporation is **NATURE COAST BUILDING SERVICES**, **INC.** It's address is 8824 E. Aquarius Drive, Inverness, FL 34450

Article II. Purpose.

This corporation is organized for the purpose of transacting any or all lawful business.

Article III. <u>Capital Stock.</u>
