Articles of Incorporation

of

ARTICLE I

NAME

The name of the Corporation is **JP Delivery Unlimited, Inc.** The principal office address and the mailing address of said Corporation is 18 Amberjack Road Ponte Vedra Beach, Florida 32082.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

CAPITAL STOCK

This corporation is authorized to issue 7500 shares of no par value stock which shall be designated as "Common Stock".

ARTICLE V

PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

INITIAL REGISTERED OFFICE AND AGENT


officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.




