ARTICLES OF INCORPORATION OF

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator of this corporation for pecuniary profit under the Florida General Corporation Act.

ARTICLE I NAME AND LOCATION OF AGENT AND OFFICES

Section 1.1 $\underline{\text{Name}}$. The name of the corporation shall be BULL GATOR BOAT TRAILER & SERVICES, INC.

Section 1.2 <u>Principal Office and Place of Business</u>. The principal office of the corporation shall be located at 4030 ANNIE STREET, SARASOTA, FLORIDA, 34233, with a post office address which is the same. The principal place of business of the corporation shall be the same as the principal office. The corporation may change the location of the foregoing offices or the post office address, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Board of Directors may from time to time determine.

Section 1.3 <u>Registered Agent and Office</u>. The Registered Agent for the corporation to accept service of process within the State of Florida shall be JANET A. BERDELL. ARTICLE II <u>DURATION AND COMMENCEMENT</u>

Section 2.1 <u>Duration</u>. The corporation shall have perpetual existence, or until dissolved according to law.

Section 2.2 <u>Commencement of Corporate Existence</u>. The corporation's existence shall commence on the date of subscription and acknowledgment hereof which date shall be no more than 5 days prior to the filing hereof by the Department of State.
