ARTICLES OF INCORPORATION

OF

CAMILLO L. FONTANA, D.M.D., P.A.

The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a professional association under the provisions of the Florida Statutes.

ARTICLE I

The name of this professional association is CAMILLO L. FONTANA, D.M.D., P.A.

ARTICLE II

The general nature of the business to be transacted by this professional association is:

(a) To engage in every phase and aspect of the business of rendering the same professional services to the public that a doctor of dental medicine, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to engage in the professional service of medicine;
