Enclosed is my Uniform Business Report for year 2002. I realize that it is filed after May 1 and the penalty should apply.

I am attempting to start some businesses, and know agriculture not tax and government rules and forms. I forward all government forms to my C.P.A. in Lakeland and rely upon him to provide me completed forms for timely filing.

When I received a notice telling me that my other corporation, Larkin Citrus, Inc. would be administratively dissolved for failure to file it's UBR, I began wondering if I had received and filed the report for this corporation.

I reviewed my records and could find no check for the fee. My C.P.A. has no record of receiving the form from me, nor do I recall ever receiving it. I looked up the corporation online, and there is no record of the report being filed. I was wondering why I had not also received a notice of dissolution for this company when I noticed that the mailing address listed by you is my physical address on Southview Ave. The post office does not deliver mail to my physical address, nor will it forward such mail to my box.

I rely on my C.P.A. to keep me straight with government paperwork, and uphold my end of this partnership by forwarding everything to him when it is received. I respectfully request that you abate the additional \$400 penalty for late filing.
