The undersigned, being at least nineteen years of age, for the purpose of forming a corporation under the Florida Business Corporation Act hereby execute these Articles of Incorporation.

ARTICLE I.  
NAME OF BUSINESS

The name of the corporation shall be Rodriguez & Guevara Corporation.

ARTICLE II.  
DURATION

The period of duration is perpetual or until dissolved in a manner provided by law, or as provided in the Bylaws adopted by the Board of Directors.

ARTICLE III.  
PURPOSE AND POWERS

In addition to the powers authorized by the laws of the State of Florida for Corporations, the general nature of business or businesses to be transacted, and which the Corporation is authorized to transact, shall be as follows:

1. To engage in any activity or business authorized under the Florida Status.
2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.
3. To purchase or otherwise acquire, undertake, carry on, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this corporation is authorized to carry on, pursuant to the provisions of these Articles; and to hold, utilize, and in any manner dispose of the rights and property so acquired.
4. To enter into and make all necessary contracts for its business with

any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

ARTICLE IV.  
CAPITAL SHARES

The number of shares the corporation is authorized to issue is 1000 shares of common stock, valued at \$1.00 per share. This capital contribution shall be paid to the corporation by the four members in the following amounts: Isabel C. Angel, \$250.00 (25%), Miguel A. Rodriguez, \$250.00 (25%), Francisco Guevara, \$250.00 (25%), and Ana M. Mora, \$250.00 (25%). Additional contribution will be made as required for investments purpose, as determined by unanimous consent of the members. Members will make contributions in equal shares.

ARTICLE V.  
FISCAL YEAR

The corporation's fiscal year ends on August 31st of each year.

ARTICLE VI.  
EFFECTIVENESS

These articles will be effective upon filing.

ARTICLE VII.

ARTICLE VIII.  
PRINCIPAL OFFICE

offices at any other place or places as the Board of Directors may designate.

ADDITIONAL POWERS

The Board of Directors has the following additional powers:

1. To set the price for shares of the corporation's stock and their action in doing so is presumed valid with the only restriction being that they cannot issue shares for less than their par value.
