ARTICLE OF INCORPORATION OF

DIGAN CARPENTRY WORKS, INC.

ARTICLE I - NAME

The name of this Corporation is DIGAN CARPENTRY WORKS, INC.

ARTICLE II - DURATION

The person signing these articles is JORGE I. MARTINEZ and his address is 13710 KENDALE LAKES DR., Miami, FLORIDA 33183.


ARTICLE XI - OFFICES


