CHARTER OF
TOWNCENTER MEDIA, INC.

The undersigned, acting as the incorporator of a corporation under Chapters 607 and 621 Florida Statutes, hereby adopts the following Charter for such corporation:

Article I

The name of the Corporation is TownCenter Media, Inc.

Article II

The street address and mailing address of the initial principal office of the Corporation in the State of Florida is 203 Villa Di Este Terrace, #105, Lake Mary, Florida 32746.

Article III

The purpose for which the Corporation is organized is the sale of media advertising and other related services. The Corporation is for profit.

Article IV

The Corporation is authorized to issue One Hundred (100) shares of stock (common, having no par value). These shares together shall have unlimited voting rights and full and equal rights to share in the profits of the Corporation and its net assets upon dissolution.

Article VIII

This Charter shall become effective immediately upon its filing with the Secretary of State of the State of Florida.

Article XIX

To the extent allowed by the laws of the State of Florida, no present or future director of the Corporation (or his or her estate, heirs, or personal representatives) shall be liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director of the Corporation. Any liability of a director (or his or her estate, heirs and personal representatives) shall be further eliminated or limited to the fullest extent allowed by the laws of the State of Florida, as may hereafter be adopted or amended.

Article X

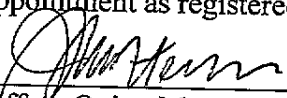
