ARTICLE VI. MANAGEMENT OF BUSINESS

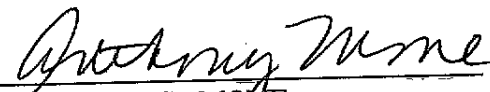

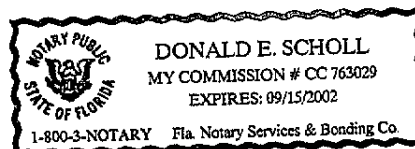
