of

ARTICLE I - Name

The name of this corporation is:

MIKE'S LIMOUSINE, INC.

ARTICLE II- Mailing Address

The mailing address of the corporation shall be:

ARTICLE III - Stock

This corporation is authorized to issue one hundred (100) shares of common stock. Each stock is to have a par value of \$1.00 per share.

ARTICLE IV - Initial Registered Office and Agent

ARTICLE V - Incorporator

The number of directors may be increased or decreased from time to time, in accordance with the laws of Florida, but the Board of Directors shall consist of at least one person.
