The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The specific purpose, and nature of business to be transacted by this corporation is to conduct as a real estate agent, mortgage broker and investment company in the State of Florida.




ARTICLE X-EFFECTIVE DATE
