ARTICLES OF INCORPORATION

OF

EPICURE SOLUTIONS CORP.

The undersigned, acting as incorporator of EpiCure Solutions Corp. (the "Company") under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME AND ADDRESS
