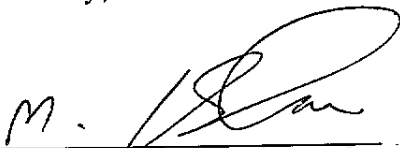

The aggregate number of shares which the corporation shall have authority to issue is **five hundred (500) at (\$1.00) One dollar per share.**

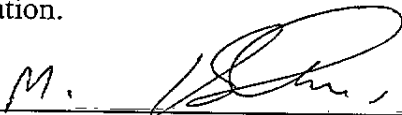
ARTICLE FIVE
