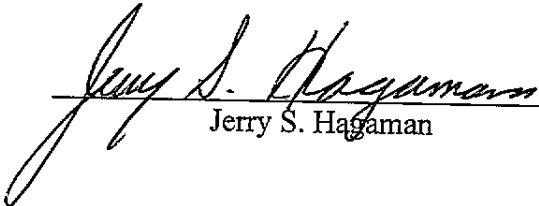
Article V – Purpose

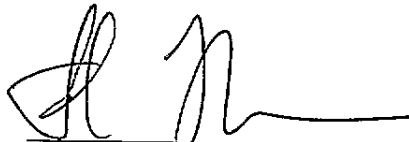
