ARTICLE ONE

The name of this corporation is: A. M. A. USED AUTO RECYCLERS INC. FLO

The principal office and mailing address of this corporation is: 1840 WEST 49TH STREET, STE. #404, HIALEAH, FL. 33012

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in a medical professional association and any activity or business related that are permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

ARTICLE FOUR

CAPITAL STOCK

BY LAWS
