**ARTICLE X-INITIAL CAPITAL**


The amount of capital with which this corporation shall begin business is not less than Five Hundred (\$500.00) Dollars.

These Articles of Incorporation may be amended in their manner provided by law. Every amendment shall be approved by the Board of Directors, proposed


by them to the members and approved at a members' meeting by a majority of the members.


