

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
INTERACTIVE DIRECT IDEAS, INC.

The following Article of the Articles of Incorporation of INTERACTIVE DIRECT IDEAS, INC. (the "Corporation") is hereby amended to read as follows:

"ARTICLE IV

CAPITAL STOCK


The capital stock of the corporation shall be divided into 500,000 shares of common stock, and each share shall entitle the holder thereof to vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, with property or in labor or services, at the valuation to be fixed by the incorporator or by the Board of Directors, at a meeting called for such purpose. All stock when issued shall be fully paid for and shall be non-assessable."

The foregoing Amendment was adopted by the written action and consent of all the Directors and Shareholders of the Corporation with voting rights as of October 1, 2001.

This Amendment shall be effective upon filing with the Secretary of State.
