The principal place of business is 250 South Central Boulevard, Suite 104A Jupiter, 33458."

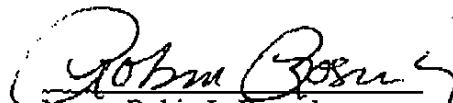
2. Article V is hereby amended in its entirety to read as follows:

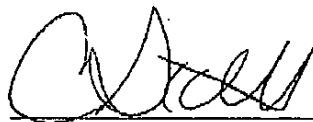
