ARTICLES OF INCORPORATION
OF
CJ MEDICAL, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I.: NAME

The name of the corporation is CJ Medical, Inc.

ARTICLE II.: PRINCIPAL OFFICE/MAILING ADDRESS


