ARTICLES OF INCORPORATION of THE GRIFFIN GROUP OF NAPLES, INCORPORATED

The undersigned, acting as sole incorporator, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I Name and Principal Office

The name of the corporation shall be The Griffin Group of Naples, Incorporated. The address of the principal office of the corporation is 505 Whispering Pine Lane, Naples, Florida 34103.

ARTICLE II Commencement and Duration

The corporation is to commence its existence on the date of the filing of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III Purpose

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be organized under Florida law.

ARTICLE IV Capital Stock

The corporation is authorized to issue and have outstanding seven thousand five hundred (7,500) shares of capital stock, which shall be designated as common stock with a par value of one dollar (1.00) per share. Par value shall have no effect on the corporation's capital structure. Each shareholder of the corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of capital stock of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or to acquire any unissued or treasury shares of capital stock.

ARTICLE VI Board of Directors

The initial number of directors appointed to the Board shall be two (2). The number of directors of the corporation may be increased or decreased from time to time pursuant to by-laws adopted by the shareholders, but shall never be less than the minimum number of directors required by applicable law.
