ARTICLE T

NAME

The name of this corporation shall be J & M MARKETING CONSULTANTS, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation is to exist perpetually, commencing at 12:01, SEPTEMBER 17, 2001.

ARTICLE III

PURPOSE OF CORPORATION

This corporation shall engage in any activity or business for profit permitted under the laws of the United States and of the State of FLORIDA.

ARTICLE IV

CAPITALIZATION
