We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit pursuant to the following Articles of Incorporation.

Article I: Name

The name of the corporation shall be CAPITAL CIRCLE PLAZA INC.

Article II: Principal Place of Business

The principal place of business of said corporation shall be in Tallahassee, Leon County, Florida, with the privileges of having branch offices at other places within the State of Florida and within or without the United States of America. The mailing address of said corporation is 2811-E Industrial Plaza Drive, Tallahassee, Florida, 32301.

Article III: General Nature of Business

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

The corporation may also engage in any other activity or business permitted under the laws of the United States of America and the State of Florida.

Article IV: Amount of Capital to Begin Business

The amount of capital with which this corporation shall commence business shall be One Hundred and no/100 Dollars (\$100.00).

Article V: Perpetual Existence

This corporation shall have perpetual existence unless sooner dissolved by law.

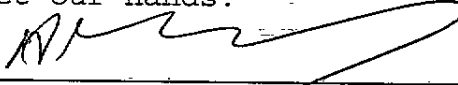
Article IX: Registered Agent

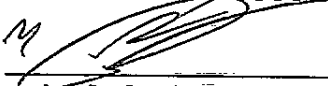
Article X: Amendments, Changes

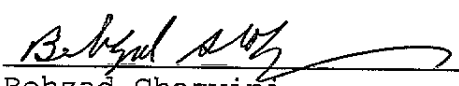

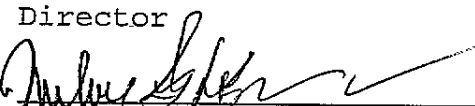

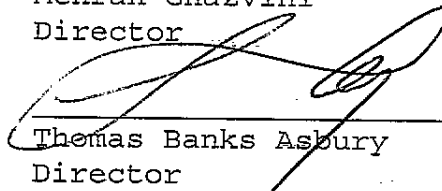
