ARTICLES OF INCORPORATION
OF
TRANSPONTS, INC.

Article I
Name

The name of the corporation shall be **TransPoints, Inc.**

Article II
Principal Place of Business

The principal place of business and mailing address of the corporation shall be **1108 NW 106th Street, Gainesville, Alachua County, Florida 32606.**

Article III
Purpose

The purpose for which the corporation is organized is the transaction of any and all lawful business.

Article IV
Shares of Stock

The corporation shall have the authority to issue 1,000,000 shares of common stock, in one class only, each with no par value.

Article V
Board of Directors

The initial Board of Directors shall have two (2) members, and the names, street addresses, and corporate titles of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

The number of directors may be increased or decreased by amendment of the bylaws of the corporation but shall in no case be less than one. The Board of Directors is empowered to make, alter or repeal the bylaws and amend these Articles of Incorporation.

Article VII
Capitalization

The corporation may issue shares of common stock for consideration consisting of cash, labor or services performed, or property actually received.

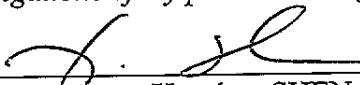
Article VIII
