In Compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") shall be B 2 A, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 502 Apache Trail, Brandon, FL, 33511 and its mailing address is 502 Apache Trail, Brandon, FL. 33511

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares. 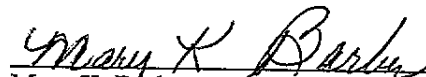
