OISEP 27 PM 3: 18 In Compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") shall be B 2 A, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 502 Apache Trail, Brandon, FL, 33511 and its mailing address is 502 Apache Trail, Brandon, FL. 33511
