ARTICLES OF INCORPORATION OF

HARWOOD CONSULTING OF MIAMI, INC.

TALLAHASSEE, FLORIDA

Vincent Harwood, the undersigned subscriber to these Articles of Incorporation, being (a) natural person competent to contract, forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Harwood Consulting of Miami, Inc.

ARTICLE II

The corporation is authorized to and may engage in any activity or business which is lawful in the State of Florida.
