NAME

The name of this corporation shall be ALL AMERICA'S HOMES, INC., with its principal place of business at 2625 Northeast Santa Fe Boulevard, High Springs, Florida 32643, with a mailing address of 14217 NW 243rd Terrace, High Springs, Florida 32643.

ARTICLE II

PURPOSE

The purpose or purposes for which this corporation is organized is the transaction of any and all lawful business within or outside of the United States of America.

Section 6. The original incorporator of this corporation shall have the right to,


and may after the organization of same, assign and deliver such subscriptions of stock herein to any

No contract or other transaction between this corporation or any other corporation shall be affected or invalidated by the fact that any one or more of the stockholders of this corporation is or are interested in, or is a director or directors or officer or officers of such corporation, and any stockholders may individually or jointly be a party or parties to or may be interested in any contract or transaction with this corporation, or in which this corporation shall be interested; and no contract or transaction of this corporation with any person or persons, firm or corporation, shall be affected or invalidated by the fact that any stock holder, or officer or officers of this corporation is a party, or are parties to, or are interested in such contract, or act, or transaction, or in any way connected with such person or persons, firm or corporation, and each and every person who may become a stock holder or officer of this corporation is hereby relieved from any liability that might otherwise exist from contracting with the corporation for the benefit of himself or any firm, association or corporation in which he may in any way be interested.



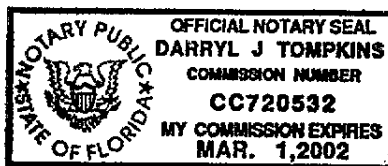


