ARTICLES OF INCORPORATION OF PHYSICIANS ADMINISTRATORS, INC.

- 1. Name. The name of the corporation is: PHYSICIANS ADMINISTRATORS, INC.
- 2. Purpose. The corporation may engage in any legal business.
- 3. Stock.
