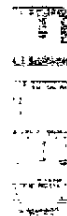

ARTICLE I-NAME

The name of this corporation is **MANLEY INSTALLATION SERVICES, INC.**

ARTICLE-II-DURATION

This corporation shall have perpetual existence commencing on October 1, 2001 at 12:00 A.M. after the filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V- PREEMPTIVE RIGHTS



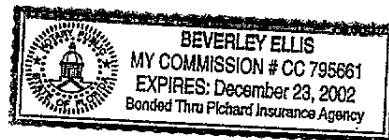
